The ACME Network is committed to protecting the privacy of your personal information. Our goal is to provide you with a unique learning experience. This Privacy Policy applies to the ACME Animation Online Website (the "Site"). The ACME Network is a California non-profit organization under section 501 (c) (3).

WHAT INFORMATION WE COLLECT

Personally Identifiable Information- In order to use our Site, you must be a participant in the ACME Animation Online Program (the "Program"). Participants are required to provide us with an e-mail address, a user name, as well as certain other personally identifying information, such as the Participant's name, and other similar information. Our practice is to not share this information with third parties except as set forth in this Privacy Policy.

Unidentifiable Information- The ACME Network also collects non-personally identifiable information (that is, information that does not identify a specific individual), such as city and state or country of residence, or other demographic information for the Services. We may collect such non-personally identifiable information in part through the use of "cookies"--that is, small text files placed on your computer's hard drive--and other



technology. Collecting this information helps us streamline your experience on the Services. You hereby agree that The ACME Network shall have the right to collect and use your information (or to authorize others to collect and use your information) as set forth in this Privacy Policy.

SURVEYS AND QUESTIONNAIRES

The ACME Network conducts surveys and/or questionnaires as part of the online experience. We do this to better deliver content and/or to better understand your needs relating to the Services. We will not share your survey or questionnaire information with any third party, except in aggregate form.

Links to Third Party Sites- The Services may contain links to other third party websites. We do not monitor or control the information collection or privacy practices of any third parties, and are not responsible for their practices or the content of their websites, including their use of any information (such as IP address, browser type, or operating system) collected when users "click through" links to their sites or view advertisements served by them. We encourage you to become familiar with their privacy practices, and to contact such third parties if you have any questions about their respective privacy policies.

WHAT INFORMATION WE DISCLOSE

Except as set forth in this Privacy Policy or as specifically agreed to by you, as a general policy The ACME Network will not disclose any Personal Information it gathers from you on our website. Notwithstanding the foregoing, we may release Personal Information to third parties to comply with valid legal requirements such as a law, regulation, search warrant, subpoena or court order or in special cases, such as a physical threat to you or others.

Evaluators- We may share Personal Information with certain third parties who perform evaluations of our Program in order to determine the quality of our program and/or to receive government or charitable grants. Access to your Personal Information by these third parties is limited to the information reasonably necessary in order for the third party to perform its limited function for The ACME Network.

Disclosure to The ACME Network Operations And Maintenance Contractors- The ACME Network's operations and maintenance contractors sometimes have limited access to your Personal Information in the course of providing products or services to The ACME Network. These contractors include vendors and suppliers that provide us with web hosting, technology, services, and/or content related to the operation and maintenance of our website and/or Program. Access to your Personal Information by these contractors is limited to the information reasonably necessary in order for the contractor to perform its limited function for The ACME Network.



INFORMATION DISCLOSED BY YOU

Participants will have the option at various places on the Site to provide personal information such as a biography that can be viewed by others accessing the Site. Such information may include name, personal interests or other personal information. Posting personal phone numbers, email addresses and mailing addresses in any biography is not allowed.

ACCESSING, CHANGING AND DELETING YOUR PERSONAL INFORMATION

If you would like to access, edit or delete your personal information, you may do so directly on the site using the personal password you have selected. If you chose to delete your personal information from our records or if you provide false information or fail to update your information, we may not be able to provide certain services to you and as such your participation in the Program may be affected.
